RULES AND REGULATIONS

1. This show is ApHCC approved and will follow the rules of the Appaloosa Horse Club of Canada. **It is the responsibility of the exhibitor to know the rules.**
2. Horses must be registered in the ApHCC.
3. To show in any ApHCC approved show you must be a member of the ApHCC. To accumulate points for year-end awards you must be a member of the NBApHC.
4. A "Youth" is an exhibitor eighteen (18) years of age or under as of January 1, 2010. Date of birth must appear on the entry form.
5. **No stallions are permitted to compete in Youth Classes.**
6. **A photocopy of Registration Papers must accompany entry forms.**
7. A photocopy of 2010 ApHCC Novice or Amateur and Membership card(s) or written confirmation from the ApHCC must accompany entry forms.
8. Fees paid will not be forfeited unless a written veterinarian's certificate can be provided.
9. **A Waiver Form MUST be completed and signed for each owner, rider and/or handler.**
10. Entry forms (**no payment necessary until Sept. 10, 2010**) are to be mailed or faxed to the following address by **Aug. 29, 2010**.
